Volunteer and Parental Permission Participation Waiver of Liability

In consideration of the opportunity afforded me or my (our) child to assist on a voluntary basis Hudson River Housing, and in light of the aims and purposes of the community service provided by Hudson River Housing, I hereby waive any rights or cause of action arising as a result of my or my (our) child's participation in said project from which any liability may or could accrue against Hudson River Housing or its officers and directors collectively or individually. Without limiting the generality of the foregoing, I agree that this waiver shall include any rights or causes of action resulting from personal injury to me or damage to my property sustained in connection with my activities. I recognize that all hazards cannot be foreseen or controlled and my participation may result in physical injury, or even death. Neither Hudson River Housing nor the cooperating sponsors and agencies have control of all the risks involved. I understand that these inherent risks may result from forces of nature, equipment failure, gross negligence, and willful and intentional misconduct or insufficiencies of the participants or leaders. By my participation in these activities I hereby assume all risks and dangers and all responsibility for any physical injury, permanent disability, or economic losses that I might incur. Furthermore, I certify that I have adequate physical health to volunteer for this event, and authorize the leaders and organizers of this event to obtain emergency medical treatment for me if necessary. I (we) agree to hold harmless and indemnify Hudson River Housing and all of the employees, members, officers and directors in connection with acts performed by them which would reasonably be associated with general beautification activities. Parental consent needed for all minor(s) under 18 to participate.

I HAVE READ THE ABOVE WAIVER/RELEASE AND ASSUMPTION OF RISK AGREEMENT AND BY VOLUNTARILY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE HUDSON RIVER HOUSING AND ALL OTHER RELEASEES, INCLUDING COOPERATING SPONSORS AND AGENCIES AND PARTICIPANTS FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH BY GROSS NEGLIGENCE AND WILLFUL AND INTENTIONAL MISCONDUCT OR OTHER CAUSE.
